The Financial Statements as set out on pages 6 to 18 have been prepared in accordance with the provisions of the "Amendment and Restatement of the Public Financial Management Act of 2009" and in compliance with the Cash Basis International Public Sector Accounting Standards (Cash Basis IPSAS 2017), adopted by the Government of Liberia.
- 2. In accordance with the provisions of the "Amendments and Restatement of the Public Financial Management (PFM) Act of 2009", I am responsible for the control of and accounting for public funds received, held, and expended for and on behalf of the Liberia Anti-Corruption Commission.
- 3. Under I-9 of the Public Financial Management Regulations of 2009, which states that: "There shall be prepared by each head of government agency and transmitted to the Auditor-General, the Minister and the Comptroller-General in respect of each quarter commencing from the beginning of the fiscal year, the accounts covering all Public Funds under his/her control".
- 4. However, I have delegated the preparation of the unaudited Final Account to the Comptroller for my transmittal to the Minister, as provided in the attendant Regulations of the Public Financial Management Act of 2009. Accordingly, I am pleased to submit the third quarter accounts of the Liberia Anti-Corruption Commission in compliance with the PFM Act and its attendant Regulations. I have provided, and will continue to provide, all the information and explanations as may be required in connection with the financial statements presented therein.
- 5. In preparing these Financial Statements, the most appropriate accounting policies have been consistently applied and supported by reasonable and prudent judgment and estimates. To the best of my knowledge and belief, these Financial Statements agree with the books of accounts, which have been properly kept.
- 6. I accept responsibility for the integrity of these financial statements, the financial information they contain and their compliance with the provisions of the Amendments and Restatement of Public Financial Management (PFM) Act of 2009 and its attendant regulation.

#### REPORT OF THE COMPTROLLER

#### **INTRODUCTION**

- **7.** This Report provides commentary and analysis of the cash receipts and payments (as well as the financial performance) of the Liberia Anti-Corruption Commission for the Third Quarter ended 30<sup>th</sup> September 2024, and its financial position as of that date.
- 8. This Financial Statement covers the third quarter (1st July to September 30th) of the budget year FY 2024, and its contents are consistent with the provisions of section I.9 Captioned "Quarterly Government Agency or fund accounts" the 2009 Public Financial Management Regulations.
- 9. The Commission has adopted a system of sound accounting and financial management policies in conformity with financial regulations of the Government of Liberia and International Public Sector Accounting Standards (Cash Basis IPSAS) to ensure prudent and efficient management of funds. The Commission shall specifically cause to be kept proper books and records of accounts for funds and resources received and expenditure incurred during the quarter.
- 10. The Commission's programs and activities are primarily funded by the Government of Liberia through budgetary appropriations. The Commission from time to time receives external support from donor partners to deliver on its legislative mandate.

#### THE FY 2024 APPROVED BUDGET

11. At the onset of the Budget year FY-2024, the Ministry of Finance and Development Planning communicated a draft budget of Two Million Sixty-Six Thousand Eight Hundred Eleven Thousand United States Dollars (US\$ 2,066,811.00) for the Commission's operations for the period under consideration (FY 2024). However, additional allocation was made to the commission affecting intelligence services and other legal fees in the tone of Nine Hundred Thousand United States Dollars (US\$ 900,000.00) which derived from Legislative adjustment needed to support the commission strategy to combat corruption in the public space.

#### **SUMMARY OF BUDGET**

12. For FY 2024, the Legislature approved a total of Two Million Nine Hundred Sixty-Six Thousand Eight Hundred and Eleven United States Dollar (2,966,811.00) to enable the commission discharge its legislative mandates of investigating, educating and prosecuting acts of corruption during the management of public finance. Of the total appropriation, US\$ 1, 200,075 representing 40% was approved for expenditure on personnel compensation whilst US\$1, 766,736.2 representing 60% was approved for spending on goods and services for FY 2024. Despite management request to procure capital items such as vehicles and land to construct the commission own facility consistent with its long term goals, no allocation was approved for capital spending for FY 2024.

The total allotment received for the third quarter from the Ministry of Finance and Development Planning stood at Eight Hundred Five-Two Thousand Six Hundred Ninety-Two United Stated States Dollars 94/100 (852,694.94).

The allotment is categorized in Table 1.0 as shown below:

- 13. The Commission rolled-out several programs in FY 2024; including: strengthening the assets declaration regime; increasing investigative caseloads from three 3 to 4 per quarter; increasing prosecution' throughout from an average of six (6) to ten (10) cases per; carried out public education, training of investigators, and education and prevention officers among others. The details and outcomes of these activities are reflected in the management's report for the third quarter report FY 2024.
- 14. To support these programs and initiatives, the Commission developed and proposed a budgetary appropriation of USD \$4.5M; however, GoL's appropriations is at USD \$2.9M. This under appropriation will challenge the Commission's ability to execute its initiatives and activities. The corresponding budgetary/appropriation shortfall is at USD \$ 1.6M as depicted in Table 1.1 below.

#### c. EXPENDITURE - OPERATIONAL FUND

In general, all expenses are recognized in the statement of Cash Receipts and Payments when paid for. Total expenditure on operational funds stood at US\$ 91, 578.00 commencing from 1st July to 30th September FY 2024.

#### d. EMPLOYEE BENEFIT/COMPENSATION

This amount represents payment to employees of the Liberia Anti-Corruption Commission for the period under review. A total of US\$ 1,200,075 was approved for spending on employees' compensation for FY 2024. For the period under consideration US\$ 149,010.09 was received and expended as actual compensation. *See schedule* 1.4 below:

#### 19. GOODS AND SERVICES

Goods and Services have to do with recurrent expenses. They include Office Stationery, Printing and Publications, Foreign Travel, Local Travel, Water and Sewage, Fuel and Lubricants for Vehicles, Fuel for Electricity Generation, Repairs and Maintenance vehicles, etc. A total of USD \$ 1,766,736.00 was appropriated for Goods and Services for FY 2024. However, total allotment against appropriation for the quarter under consideration stood at US\$ 553,311.00; while actual expenditure on goods and services stood at US\$ 91,578.00 at the closed of the third quarter.

#### **PROJECT FLOWS**

The Commission will roll-out several projects for FY-2024; these projects will be financed either through GoL allotments, or loans and grants from other partners. These projects are designed to improve and strengthen the human and institutional capacity of the Commission, as well as execute several critical anti-corruption initiatives in the fight against corruption.

#### a. OUTSTANDING COMMITMENTS

At the end of Quarter Three, the Commission has no commitments outstanding.

#### b. CASH BALANCES

The consolidated cash balances brought forward at the beginning of the quarter stood at US\$ 26,117.36. However, total cash received during the reporting period was recorded at US\$ 584,879.09. At the end of quarter under review, reconcilied cash balances consolidated stood at US\$ 360, 408.00.

#### c. Conclusion

The Financial Statements for Quarter 3 ended 30<sup>th</sup> September 2024, should be read in conjunction with the underlying notes and supplementary disclosures for better understanding and interpretation.

## 23. NOTES OF EXPLANATIONS AND ELABORATION RELATING TO THE FINANCIAL STATEMENTS

24. The numbered notes that follow relate directly to the content of the Financial Statements above and are numbered accordingly.

#### 25. GENERAL INFORMATION - REPORTING ENTITY

The Financial Statements are for the Liberia Anti-Corruption Commission, a public sector entity of the Government of Liberia. The financial statements encompass the reporting entity as specified in the relevant legislation (Public Finance Act 2009). Liberia Anti-Corruption Commission principal activity is to implement appropriate measures and undertake programs geared toward investigating, prosecuting and preventing acts of corruption, including educating the public about the ills of corruption and the benefits of its eradication.

26. The Financial Statements presented above reflect the Cash Receipts and Payments of the Liberia Anti-Corruption Commission for the quarter ended 30th September 2024 on the basis of moneys received by, held in or paid out by the *Liberia Anti-Corruption Commission* during the quarter under review. The LACC controls its own bank accounts. Appropriations and other cash receipts are deposited into its bank accounts, from which cash expenditures are administered upon presentation of appropriate documentations and authorisation.

#### **27.ACCOUNTING POLICIES**

These are the specific principles, basis, conventions, rules and practices adopted by the Government of the Republic of Liberia in preparing and presenting the financial statements. The principal accounting policies adopted in the preparation of the financial statements therein are set out below.

#### a. BASIS OF PREPARATION

These financial statements have been prepared in accordance with the requirements of the Amendments and Restatement of Public Financial Management Act, 2009 and comply with the Cash Basis International Public Sector Accounting Standard (Cash Basis IPSAS 2017): Financial Reporting under the Cash Basis of Accounting. The measurement basis applied is the historical cost basis, except where otherwise stated in the accounting policies below. The accounting policies adopted have been consistently used throughout

# (b) REPORTING CURRENCY AND TRANSLATION OF FOREIGN CURRENCIES

The reporting currency is the United States Dollars and the exchange rate is 193.19 LD to 1 USD.

#### (I) FUNCTIONAL AND PRESENTATION (OR REPORTING) CURRENCY

The Republic of Liberia operates a dual currency regime comprising the Liberian Dollar (LD) and the United States of America Dollar (US \$) both of which are legal Tender. The attendant Financial Regulations to the PFM Act of 2009 states that:

"the monetary unit of Liberia for all government agency accounting and financial reporting shall be the Liberian Dollar. The United States Dollars may also be used for financial reporting purposes, but the Liberian Dollar is the base currency."

Hence, for the purpose of the Financial Statements being submitted, the United States Dollar is used as the reporting currency, which is permitted under the attendant Financial Regulations to the PFM Act of 2009 and adopted by the Government of Liberia as its reporting currency.

#### (ii) TRANSLATION OF TRANSACTIONS IN FOREIGN CURRENCY

Foreign currency transactions and transactions in Liberian Dollar and other foreign currencies are translated into United States Dollar using the exchange rates prevailing at the dates of the transactions. Closing monetary balances are translated into the reporting currency using the closing rates. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the statement of financial performance.

The Quarter ended (30th September 2024) exchange rate for the Liberian Dollar was 193.19 LD to 1 US \$.

#### (b) **REPORTING PERIOD**

The reporting period for these financial statements is for the Third quarter ended September 30th of 2024, of the Government, which runs from 1st July 2024 to 30st September 2024.

#### (c)PAYMENTS BY THIRD PARTIES

The Commission had no third-party transaction for the period under review.

#### (d)RECEIPTS

Receipts represent cash received by *LIBERIA ANTI-CORRUPTION COMMISSION* during the financial quarter, comprising Authorised allocations/appropriations. Receipts are recognized as follows:

#### (i) AUTHORIZED ALLOCATIONS/APPROPRIATIONS

Authorized Allocations are recognized when they are received and under the control of the Liberia Anti-Corruption Commission. For the Third quarter ended 30<sup>th</sup> September 2024, the commission received Five Hundred Eighty- Four Thousand Eight Hundred Seventy-Nine United States Dollars (584,879.09) 09/100

#### (ii) Grant

Grants are recognized when received. Similarly, grants/transfers to other entities of Government are recognized when disbursement is made.

#### (iii) OTHER RECEIPTS

Other Receipts are fees/charges collected and proceed from sales of designated services. Sales of services are recognized in the period in which the payment for the service is received and not necessarily when the service is rendered. Other Receipts, whether directly collected by the Commission or collected by another entity on its behalf is recognized when received and under its control of the commission.

#### (c) EXPENSES

In general, all expenses are recognized in the statement of Cash Receipts and Payments when paid for.

#### (d) PROPERTY, PLANT AND EQUIPMENT (PHYSICAL ASSETS OR FIXED ASSETS)

Property, plant and equipment principally comprises land, buildings, plant, vehicles, equipment, and any other capital assets controlled by the Commission.

Under the Government's cash basis of accounting, purchases of property, plant and equipment are expensed fully in the year of purchase. However, a memorandum record is maintained in the Fixed Assets Register at historical cost for all non-current assets of the Commission. Unrealized gains or losses arising from changes in the values of property, plant and equipment are not recognized in the financial statements. Proceeds from disposal of property, plant and equipment are recognized as other receipt in the period in which it is received

#### (e) INVENTORIES

Consumable supplies are expensed in the period in which they are paid for.

#### (f) EMPLOYEE BENEFITS

Employee benefits include salaries, wages, allowances, pensions and other relatedemployment costs. Employee benefits are recognized when they are paid. No provision is made for accrued leave or reimbursable duty allowances.

#### (g) CONTINGENCIES

Contingent liabilities are recorded in the Statement of Contingent Liabilities (on memorandum basis) when the contingency becomes evident and under the cash

accounting method they are recognized only when the contingent event occurs and payment is made. Contingent assets are neither recognized but disclosed where probable.

#### (h) COMMITMENTS AND GUARANTEES

Long term Commitments, including operating and capital commitments arising from non-cancellable contractual or statutory obligations as well as Guarantees made, will be reported as Notes to the Financial Statements.
