**REQUEST FOR PROPOSAL FOR PROCUREMENT OF PRIVATE SECURITY GUARD SERVICES**

1. The Liberia Anti-Corruption Commission has received budgetary appropriation from the Government of Liberia through the Ministry of Finance and intends to use portion towards the procurement of Private Security Guard Service.
2. The Liberia Anti-Corruption Commission intends to enter into a contract with a competent and reputable Security Firm. This contract shall cover 6 consecutive months from 01 July 2021-31<sup>st</sup> December 2021. Selected firm shall provide security services to all LACC offices and premises as required by the LACC Policies.
3. The LACC now invites sealed bids from eligible and qualified bidders for the provision of the aforementioned services.
4. Bidding is conducted through the National Competitive Bidding (NCB) procedures specified in the PPCA and is opened to all eligible bidders in Liberia, as defined in the Act.
5. Interested eligible bidders may obtain further information from the Procurement Unit located on the ground floor of the Liberia Anti-Corruption Commission, adjacent the French Embassy in Congo Town, Monrovia Liberia.
6. Tender Documents can be picked up from May 19<sup>th</sup>, 2021 to June 17<sup>th</sup>, 2021, beginning 10:00 a.m. to 4:00 p.m., Mondays through Fridays. Tender documents can be purchased for a non-refundable fee of at **USD \$25.00**.
7. Sealed bids must be delivered to the Procurement Unit not later than **4:00 p.m. on 17/05/21**. Late bids will be rejected and returned unopened. Bids will be opened in the presence of bidders who choose to attend or their representatives on **17/05/21 at 4:10 p.m. on the ground floor, in the meeting room of the Division of Administration**.
